financed shall be charged. However, the administrative fee shall not exceed One Hundred Dollars (\$100.00). (5-18-87)

4. Interest at the rate of eleven percent (11%) per annum shall be charged. Rates may be reviewed annually. (5-18-87)

5. New commercial development with a NUFF exceeding \$10,000.00 shall have the option to pay the NUFF over a period not to exceed five (5) years provided a written contract is executed and a lien against the property is recorded specifying that the contract must be paid in full upon sale or change in ownership of the property. Interest shall be at the prime rate plus one percent (1%) with an annual adjustment every January 1st. An administrative fee of two and one-half percent (2-1/2%) of the amount financed, not to exceed One Hundred Dollars (\$100.00), shall be assessed. (10-17-88)

II. SEWER SERVICE DEPOSIT FEE

The deposit for initial service shall be an amount equivalent to two (2) months total sewer service fees based on the ER designation of the user.

III. SEWER SERVICE FEES

A. Sewer service charge: (effective for the January 2015 billing cycle – Resolution No. 14-60)

IV. MAIN EXTENSION AND INSPECTION FEE FOR SUBDIVISION AND OTHER DEVELOPMENTS

This fee shall be \$50.00 per subdivision lot, per multi-family residential unit, and \$50.00 plus actual costs @ \$30.00 per hour for commercial and shall be paid by the developer at the time request for water service is made. (10/18/06 – Resolution No. 06-76). A deposit of **\$150** shall be applied toward the cost for Cured in Place Pipe (CIPP) Lined Sewer Main Connection for new construction only. (12/17/14 – Resolution No. 14-60)

V. MAIN EXTENSION ENGINEERING FEE:

There shall be collected by the city a non-refundable fee of Fifty Dollars (\$50.00) as an engineering review fee at the time of application for a sewer main extension on per lot for subdivisions, per unit for multi-family residential, and per 1,000 square feet for commercial. (10/18/06)

VI. PRETREATMENT MONITORING, INSPECTION AND SURVEILLANCE PROCEDURE FEES

This fee shall include all costs incurred by the City in the performance of its pretreatment monitoring, inspection and surveillance duties, plus an administrative fee of \$25.00.
